

## Evidence of Identity Requirements

**Applicants need to provide evidence of identity as follows: -**

- **Tasmanian Driver's Licence with correct name and address details**  
(can be expired up to two years)

**If you are unable to provide a driver's licence, the following documents are required:-**

- **One Document from CATEGORY A and two documents from CATEGORY B**

**OR**

- **Two documents from CATEGORY A and one document from CATEGORY B**

<b>Australian Birth Certificate</b> (Not an Extract or Commemorative Certificate)	<b>Medicare Card</b>
<b>Australian Photo Driver Licence</b> (can be expired up to 2 years)	<b>Bank or Credit Card</b> with signature
<b>Australian Passport</b> (can be expired up to 2 years)	<b>Student Identity Card</b> with photo (issued by an Australian educational institution)
<b>Overseas Passport/Visa</b> (can be expired up to 2 years)	<b>Concession Card</b> (Veteran's Affairs / Centrelink / other current entitlement issued by the Australian Government)
<b>Australian Firearms Licence</b>	<b>Births, Deaths &amp; Marriages Change of Name / Marriage Certificate / Deed Poll</b> (not a Church or Celebrant document)
<b>Tasmanian Government Personal Information Card</b> (displaying full name)	<b>High Risk Work Licence</b> (issued by WorkSafe Tasmania)
<b>Australian Citizenship papers</b>	<b>Working with Vulnerable People or Children Card</b> (issued by the Australian Government)
<b>Travel Documents or ImmiCard</b> (issued by Department of Immigration & Border Protection or Australian Government)	
<b>Certificate of Evidence of Resident Status</b> (issued by Department of Immigration & BorderProtection)	

**At least one document must confirm your current Tasmanian residential address. Additional evidentiary documentation may be required from Evidence of Residential Address section below.**

## **EVIDENCE OF RESIDENTIAL ADDRESS**

**Documents must be less than 6 months old**

- Financial Institution Statement
- Utility Account (power, water, telephone)
- Council Rate Notice
- Lease or Rent Agreement
- Land Tax Valuation Notice
- Australian Taxation Office Assessment (current or last financial year)
- Certificate of Title

## **PROVISIONAL APPLICANTS**

**Provisional Applicants unable to provide any of the above documentation to confirm a current Tasmanian residential address may provide one of the following:**

- Copy of Driver's Licence of either parent (as identified on Birth Certificate)
- Letter from current school confirming enrolment and address
- Concession Card – Provisional applicant as listed dependent

## **EVIDENCE OF CHANGE OF NAME REQUIREMENTS**

**Applicants must provide the following:**

- Adoption paper issued by Court
- Divorce Paper issued by Court, indicating the name being reverted to
- Change of Name Registration issued by Births, Deaths & Marriages or Deed Poll
- Guardianship Order
- Marriage Certificate issued by Births, Deaths & Marriages (not a Church or Celebrant issued document)
