MARINE AND SAFETY (FEES) AMENDMENT BY-LAWS 2023

The Marine and Safety Authority makes the following by-laws under the *Marine and Safety Authority Act 1997*.

1. Short title

These by-laws may be cited as the *Marine and Safety (Fees) Amendment By-laws 2023*.

2. Commencement

These by-laws take effect on 1 July 2023.

3. Principal By-laws

In these by-laws, the *Marine and Safety (Fees) By-laws 2020* are referred to as the Principal Bylaws.

4. Clause 3 amended

Clause 3(2)(b) of the Principal By-laws is amended by omitting *Marine and Safety (Motor Boats and Licences) By-laws 2013* and substituting *Marine and Safety (Motor Boats and Licences) By-laws 2023*.

5. Clause 4 amended

Clause 4(1)(b) of the Principal By-laws is amended by omitting *Marine and Safety (Motor Boats and Licences) By-laws 2013* and substituting *Marine and Safety (Motor Boats and Licences) By-laws 2023*.
